- ☐ You must have a valid class 7 (or better) driver’s license to operate a golf cart on public property.
- ☐ You must maintain third-party liability insurance of \$200,000 for yourself, and all other operators, to operate a golf cart as permitted by Bylaw No. 9-2023 and the Motor Vehicle Safety Regulations.
- ☐ You must be able to produce identification, a copy of insurance, or other required information as may be requested by any designated officer.
- ☐ Your golf cart must have a slow-moving warning sign attached, and clearly visible, at the rear of the golf cart. The slow moving warning sign shall be affixed as near to the center as practicable with one side parallel to and not less than 900 millimeters not more than 1,500 millimeters from the ground, as per Section 2 (1)(kk)of The Vehicle Equipment Regulations. It is recommended to install cart a rear viewing mirror, or mirrors, on the golf cart so as to see any upcoming traffic behind the golf cart.
- ☐ Anyone operating a golf cart shall not tow anyone or thing, nor operate with anyone standing, and shall not operate on the walking path along 2nd Avenue and Baltimore Street or the walking path in Memorial Park, or when winter driving conditions are present.
- ☐ As an owner you are responsible for the operation of your golf cart and may be held liable for violations and/or damage as a result of the operation of the golf cart.

Declaration of Owner applicant

To the maximum extent permitted by applicable law, in no event shall the Village of Borden, its elected officials, officers, employees, agents, volunteers, contractors, and representatives be liable for any action arising as a result of this application and shall forever be released from any and all actions, expense, claims, or demands that I, any authorized or unauthorized persons using my golf cart, my assignees, heirs, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to my issuance of a registration plate and authorization to lawfully operate a golf cart as permitted by Bylaw No. 9-2023 and the Motor Vehicle Safety Regulations, as a low-speed vehicle.

I further understand it is my sole responsibility to comply with any and all other municipal, provincial and federal law, and that I undertake to ensure anyone using my golf cart operates in a safe and lawful manner. I have carefully read these requirements and fully understand its contents and that I undertake to sign it of my own free will. I further certify that all statements contained within this application are true and I make this application knowing and believing them to be true.
